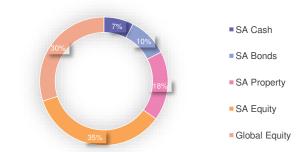

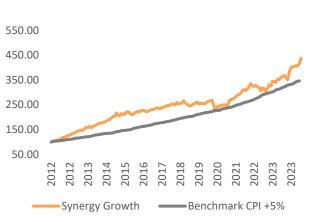

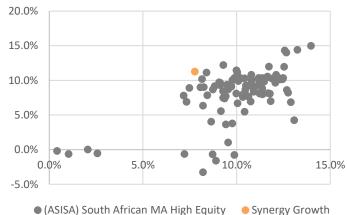


### PARTICIPATION CHARACTERISTICS\*\*
