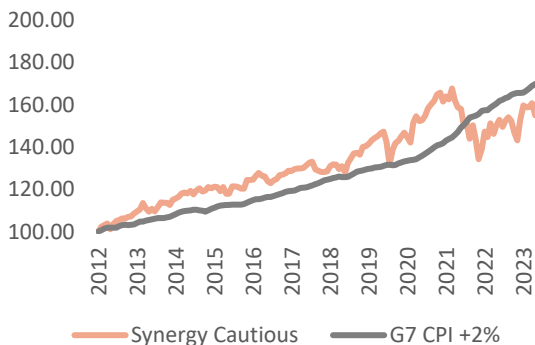

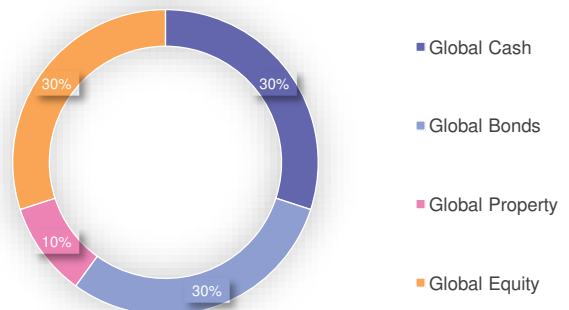

### LONG-TERM GROWTH\*



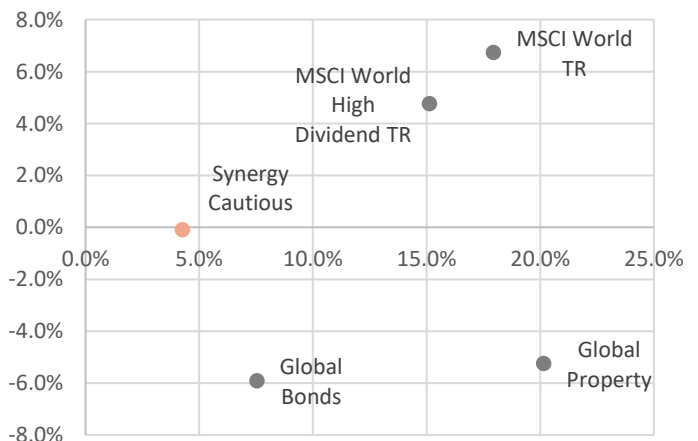
### ASSET ALLOCATION
