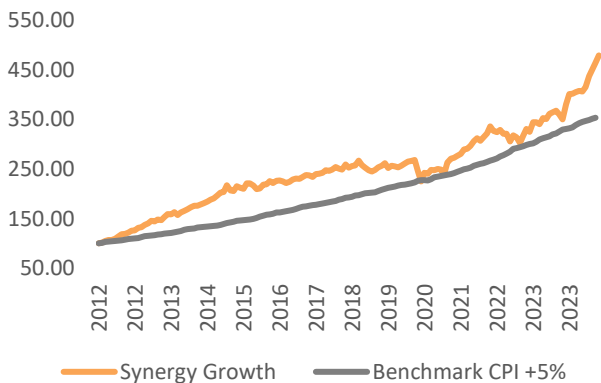

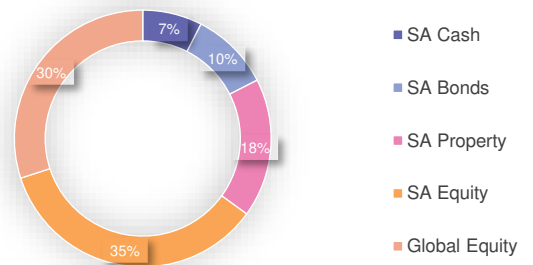

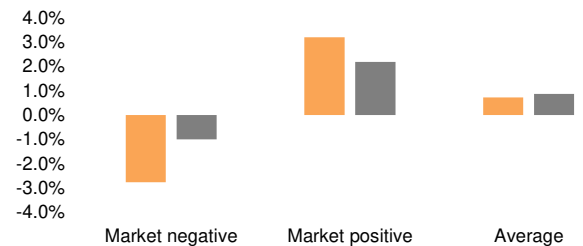
## LONG-TERM GROWTH\*



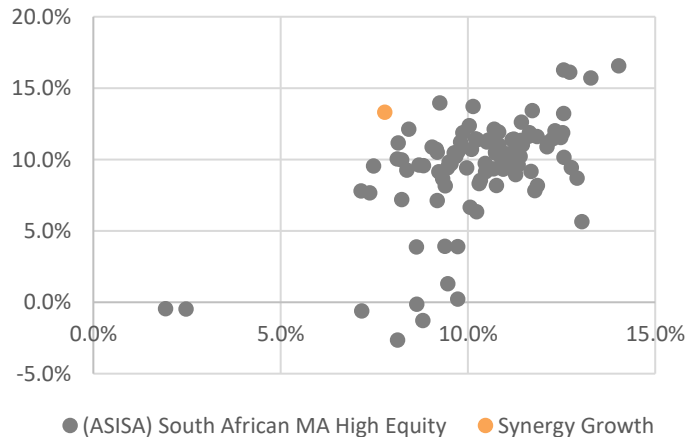
## ASSET ALLOCATION
