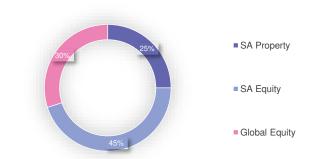

# **ASSET ALLOCATION**



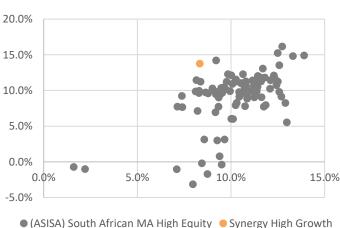
### PARTICIPATION CHARACTERISTICS\*\*
